Seller may change credit limits or other credit terms at any time at its sole discretion. No modifications may be made otherwise to credit terms except in writing signed by an officer or seller.

Customer agrees that any amount not paid within 30 days of invoice date will carry interest at the rate of 1 1/2% per month, both before and after judgment and further agrees to pay all costs incurred in collection, including attorney's fees in the amount of 1/3 of the total balance due if this account is placed with an attorney for collection, whether suit is filed or not. Customer expressly agrees to submit to personal jurisdiction in Colorado and agrees that the forum for any litigation pursuant to the Agreement or any other contract between Seller and Customer, whether Seller or Customer brings suit, shall be in the County of Pitkin, Colorado. This agreement shall be governed by and construed in accordance with the laws of Colorado.
3. All mechanic's lien, payment bond or similar waivers or restrictive endorsements on checks shall be effective only to the total dollar amount of payments actually received without any bankruptcy filing for ninety days thereafter. Customer agrees that Seller retains its mechanics lien, payment bond or other legal rights for unpaid invoices, regardless of what other waiver documents may imply otherwise. Customer further agrees that seller has the right to determine, in its sole discretion, how to apply payments and which invoices to pay with all payments received on the account despite any advice to the contrary.
